- 1. Approval of the Agenda Casey motioned, Dionne seconded, agenda approved unanimously.
- 2. Approval of 2/21/2019 Meeting Minutes amend minutes and strike 7c ii. Point of clarification on GD 260 related course demand data. Casey motioned, Todd seconded, amended minutes approved unanimously.
- 3. Associate Dean's Remarks
 - a. My Spartan Story and Spartan Experience mystory@msu.edu creating a co-curricular record to document co-curricular learning at MSU. This will turn into a co-curricular transcript that will go along with their normal transcript. You can enter student learning experience into the systems, but can add anything that is credit bearing since that would hit the typical transcript. We can also use this to pull data on what students are doing, as well as being mindful of accessing student data. Pedagogical and assessment theory was applied to this system as well as research modules associated with the independent study form.

6. Curricular Items

English Package presented by Emery Petchauer:

- a. Popular Culture Studies MNUN (English) New Minor
 - i. Created to elaborate existing strengths within the department and university surrounding popular culture.
 - ii. Discussion on how the courses tie in properly or not to the minor.
 - Requests:
 - a. #15 Description: Take out ENG 493 internship course because of how the system would already pick up as completed for the student, and move it to 'or an approved course' the same way the electives are listed.
 - b. #15 Description: Think about rephrasing 3 credits from 1-2 of the following courses
 - c. Get sign-off from AAHD as it relates to the Comics Minor
 - d. Table the ENG package for the next meeting based on completion of all of the requests.
- b. ENG 340 Course Change
 - i. Discussion on prerequisites (#22) as it applies to the minor or to any one student that takes the course.

7. Experiential Learning Forms

Presented by Gretel Van Wieren and Arthur Versluis

The department did a call to review experiential based courses, and none of those courses were submitted for experiential learning except the following. These courses work closely with non-profit organizations by site visits, volunteering, meeting with directors, and focusing their final projects and reflections on those experiences.

- a. REL 101, REL 220, REL 485
 - i. Requests:
 - Remove some of the unnecessary information (following "the exact type of meetings..." from #9 and add more information into #10 to explicitly state how these fulfill EL, but that students don't need to fulfill EL within their own departments (i.e. and internship). For example, 5-10 site visits and guests speakers, but that these courses vary with instructors.
 - ii. Discussion on the information provided within the form and how specific or granular certain information needs to be since the form has been altered a few times since its inception.
 - iii. Motioned by Dionne, Emery seconded EL courses unanimously approved with the completion of the requests above.
