    - New 100 level course as no other 100 level courses exist within the program, & expanding the class size beyond 30

- Recommendation to update typo in #1, and remove associated items in #7 from the previous iteration.
- Miguel motioned, Brandon seconded, course approved unanimously with the small recommended changes.
