- 1. Approval of the Agenda Justin motioned, Kristin seconded, agenda approved unanimously.
- 2. Approval of 2/18/2020 Meeting Minutes Chris motioned, Kristin seconded, minutes approved unanimously.
- 3. New Major Patti Spinner
  - a. Possible title: Language for the Professions
    - i. A degree for working with speakers of second or other languages in education/government/nonprofit etc.
    - ii. Practical skillset for learning a language and culture
      - Searching for feedback
      - Mostly comprised of currently offered courses
  - b. New major geared towards the languages and working with people in other languages
    - i. A TESOL major would be too narrow and too small to sustain
      - Not enough courses in TESOL currently
  - c. No tracks or concentrations, but does have focus areas
  - d. Goal is to bring in new majors and not take away from others
  - e. Feedback:
    - i. Linguistics wanted more of a goal and focus to the major
      - Recommendation was to start as a minor
    - ii. Do peer institutions have similar successful programs?
    - iii. Can there be cross-listed courses, internships, or a certification instead of a major?
    - iv. Label as tracks so they're clear to students and identifies an outcome
    - v. Student/Scenario examples:
      - Spanish
      - Language teachers who want to teach abroad
      - Study abroad office, working with international students, international scholars, and refugees.
      - Solving language problems
      - Practical program that can applied to different fields

    - ii. Wellness checks done by campus police offers
    - iii. Situations where students are forced to head home to places that might not be safe for them
    - iv. Student online class forums have created some bullying aspects
  - b. What do we do as a college, as their professor, as a committee?i. Student experience, student lives, and our duty to them
  - c. Recommendation to document some of these experiences that we can revisit at the next meeting and to take to other venues
