- 1. Approval of agenda and minutes from September 2020
  - a) Amy motioned, Xia seconded, agenda approved.
  - b) Kathryn motioned, Amy seconded, minutes approved.
- 2. Selection of interim Chair Kate Sonka has self-nominated
  - a) Committee agreed with self-nomination of Kate Sonka as Interim Chair
- 3. Student emergency funds update Christine Radtke
  - a) Senior Director of Development
    - Gifts & Endowments
  - b) History of student emergency fund:
    - Started in 2018, first gift was in September for \$25
    - Has become a strong priority in CAL
    - Part of our annual fund letter ask, greenline, giving day, crowd campaigns
    - Now sitting at roughly \$32,000 from about 150 donors
    - 2020 focus on art supplies for students
    - Cara has insights on the awards, how the funds are dispersed, etc.
      - More info coming from Cara next month
      - There is coordination with departments on fund distribution
- Remarks by Associate Dean Sonja Fritzsche (Engaged Pedagogy grants; Inclusive Pedagogy Initiative, CAL Demographic Data – Teams folder; Guest from LGBTQ Center – Jesse Beal)
  - a) 2020 Demographic Data will be coming soon once we receive the raw numbers from AHR

- DEI can always be improved
- b) Jesse Beal would like to have a discussion with the committee, but is unable to meet at our normal time can we have a special meeting date for this topic?
  - Recommendation of forming a subcommittee to meet on another date with Jesse and bring the pronouns discussion back to the full committee
  - Kate and Leann will send a poll to see who is interested and able to meet when Jesse is available
- 5. IDEA coordinator update (Kate and Ellen)
  - a) New Chief Diversity Officer meet and greet at the last meeting
    - Council of Diversity Deans was a part of this selection
  - b) Discussion around training program for IDEA Coordinators to become facilitators for diversity in the classroom
  - c) Discussion about election events
    - The day after moving forward post-election event: Faculty who have experience breaking this down to the community

    - Beyond understanding how observations are different
    - Pandemic online learning is different than normal online learning
      - Understanding of caregiving responsibilities, etc.
