- 3) Overview of Department of English Equity and Justice Committee activities by guests Julian Chambliss and Lamar Johnson.
 - They were asked by the Chair [of English] to come and speak with CIPC. They have a number of charges from the Chair. They have been in place for 3 years or so and have grown.
 - There isn't a particular agenda for the committee. However, they are looking at a set of charges. They are creating a mission and vision statement for the department. Looking at a universal syllabus as well as a curriculum vision statement.
